A MESSAGE FROM THE CHAIR OF THE KSKJ LIFE NATIONAL **BOARD OF DIRECTORS**



KSKJ Life is excited to be celebrating our 125th Anniversary as a Fraternal Benefit Society! We became an official organization on April 2, 1894. It was the Slovenians coming to America that created the need to form Fraternal Benefit Societies, and it became the compelling reason for our founders to establish the "KSKJ". Throughout this whole

year, lodges will be hosting events to celebrate both our proud heritage and for having successfully survived this long. KSKJ Life, American Slovenian Catholic Union has had a vibrant history. There were many years of good times, as well as difficult times. Through it all we prospered and continued to serve and protect our members.

As I looked back through our many years, there were some noticeable events in history that greatly impacted KSKJ. I thought it might be interesting information to share with you some of these more prominent events. (See pages 8-9 for a timeline of events).

Most recently, the 39th National Convention was one of those special times when our membership sets in motion the future of our organization for the next four years. The Quadrennial National Convention held last August provided an opportunity for our membership to define the future direction of our great Fraternal Benefit Society. Every four years, lodges elect the delegates to represent their members at the National Convention.

What are some of the messages that our delegates conveyed at the 2018 National Convention?

The programs and initiatives that we have put in place are still driving a connection and providing an impact to our members and communities. More particularly, the Educational Grant Program and the Matching Funds Program are two programs that enhance our mission. Our life insurance products and annuities are very favorable. Lodge members voiced they want more local fraternal events and agree that the Home Office must provide the resources, but the local lodges must take the lead to make it happen. The opportunity for the lodge Fraternal Activities

Coordinators to participate in a committee that gives input on the national level through regular conference calls is seen as a great opportunity for local lodges to be heard. Member communications is an area that always seem to present challenges. Our delegates told us that they like the KSKJ VOICE, but they don't always read it. Some admitted to never reading it and further indicated they prefer email or texting as the best way to communicate. The opportunity to get better at sharing our message is an ongoing task. Trying to find the one right "medium" that meets everyone's needs and expectations is perplexing. We will be introducing enhancements and new ways to get our information to you and your lodges. Our focus will be to continue to look at improvements, so expect things to get better.

Our growth and financial success continue to be the result of exceptional leadership and sound business decisions. The past board and newly seated board from the 2018 National Convention remain committed to providing our members with financial products and member benefits that will insure a lifetime commitment from those we serve. We have had exceptional success and will continue to preserve those things that work and change those that need to be improved.

AMERICAN SLOVENIAN EDUCATION FOUNDATION GALA

Along with officers and members from Lodge #236 in San Francisco, Rudy Krasovec, Chair of the Board, and Tony Mravle, CEO, had the honor of attending the annual ASEF Gala on March 16, 2019. The American Slovenian Education Foundation was founded to offer student exchange programs between Slovenians in the US, Canada, UK, Australia, New Zealand and Slovenia to enable research, innovation and entrepreneurship exchange. Founded in 2014, ASEF celebrated its 5th anniversary at this event and is projecting to have nearly 40 students in the program this year with over 40 universities participating as well. Several KSKJ Life members have been awarded grants to participate in ASEF, most recently Matthew Fitzsimmons from Lodge #257 in Washington, DC and Lacey Viano from Lodge #108 in Joliet, Illinois.

As part of the festivities, ASEF presented Professor Mia Rode with the ASEF Lifetime Achievement Award. Among many of her accomplishments and years of service, in recent years Mia has devoted herself to designing and teaching Slovene language courses online and in San Francisco at Club Slovenia. Mia also played a vital role in establishing Stanford University's first Slovene Language program and was appointed to a professorial position teaching graduate and undergraduate students.

Many KSKJ Life members were in attendance at the event and several also serve on the ASEF Board of Directors, including Jozi Plut and John P. Vidmar. A video message from Borut Pahor, President of the Republic of Slovenia, was presented, and everyone was also honored by the attendance of Stanislav Vidovic, Slovenian Ambassador to the United States.

ASEF has already made great strides in just five years, and it counts on donations and host families to support the young adults that seek to participate in this very successful program. Each month we will feaure a couple of the submissions received. Thank you Chuck Racki and Elizabeth Sebastian for sharing your KSKJ stories with us!

St. Joseph Lodge #2 was organized May 6, 1890 and admitted to the KSKJ April 2, 1894. The total number of members numbered 25, but some of the names are not known today. Those that are known are: Joseph Stukel, Peter Jevcek, Martin Fir, Frank Zlogar, Math Bezek, Mark Nemanich, Marko Plut, John Zmajic, John Stopnik and Anton Golobich. The first lodge officers were: Peter Jevcek, president and lodge representative; John Zmajic, vice president; Joseph Stukel, financial secretary; John Stopnik, recording secretary; Anton Golobich, treasurer; and Martin Fir, sergeant-at-arms. Through the years, St. Joseph Lodge 2 has encouraged its members to participate in charitable works that benefits families and their communities. Present day activities include participating in Join Hands Day, Annual Steak Fry, Easter Egg Hunt, Matching Funds events and sporting events. Congratulations, Lodge #2, for 125 years and thank you for all that you do!

As we look back at the many events that helped to build our great organization, one thing is clear: it was our loyal members who made it all possible. They were the backbone of every event. It was through the support of our member and families that we have been able to sustain our great history. - Rudolph Krasovec

1890 - Slovenians and Croatians started to leave Eastern Europe and move to America. They settled in New York, Pennsylvania, Ohio, Illinois, Minnesota, Wisconsin, Michigan, Missouri, Kansas, Colorado, Wyoming, Utah, Montana and California. They moved to the cities where there was work in the mines, smelters, steel mills and farms.

1893 - Father Francis S. Sustersic, pastor of the Slovenian Parish, St. Joseph's in Joliet, Illinois, became the organizing influence among Slovenian communities and is credited with helping to organize the KSKJ.

1894 - Kranjsko Slovenska Katoliska Jednota KSKJ, (Carniolian Slovenian Catholic Union) was founded by the uniting of 10 Fraternal Benefit Societies, or what we now call lodges. Joseph Stukel was the first KSKJ President. There were 333 initial members. The initial lodges that are still in existence are: St. Stephan's Lodge #1 in Chicago, Illinois; St. Joseph's Lodge #2 in Joliet, Illinois and St. Joseph's Lodge #7 In Pueblo, Colorado.

1898 - KSKJ applied to be Incorporated in the State of Illinois.



1904 - Women were invited to become members of KSKJ.

1909 - The first KSKJ Home Office was built.



1915 - First issue of the official newspaper "KSKJ Glasilo" the VOICE was published.

1934 - A new Home Office Building was built in downtown Joliet.

1941- Pearl Harbor attacked. The United States entered World War II.

1942 - With our Nation at war, 1,203 KSKJ members enlisted and served in the military.

1959 - KSKJ Membership peaked to over 50,000.



1962 - The Silver Convention in Steelton/Harrisburg, PA. Our name was changed to American Slovenian Catholic Union, KSKJ.

1968 - KSKJ Scholarship Fund was established and a committee was formed to administer the fund.



1980 - Construction of the 1st new Home Office Building at our current location in Joliet.



1995 - Matching Funds program was started.

2002 - Orlando Florida Convention. Assets hit \$50 million. Membership was 24,354.

2006 - Washington DC Convention. Our name was changed to KSKJ Life, American Slovenian Catholic Union.

2010 - Medicare Supplement was introduced and became a viable source for new members.



2012 - National Board was split into 2 separate boards: Financial Board and Fraternal Board, which later became the Fraternal Committee in 2017.



2015 - Introduced New Educational Grant Program. Since its inception, we have awarded \$383,000 in educational grants and scholarships making it one of our premier member benefits.

2017 - New Home Office building purchased and dedicated, which expanded our current campus.

2018 - At the end of the year, our assets were \$513 million, and membership grew to over 40,000. Current number of active lodges is 34.

APRIL IS FINANCIAL LITERACY MONTH

Message from KSKJ Life Board Chair, Rudy Krasovec: The following Essay was written by my niece Jillian Parsons from Overland Park, Kansas. She wrote it about her grandmother and my mother. Thought our members might enjoy this and it would be worth sharing especially during the Easter season.

Slovenian Heritage has a special meaning, to Bernice Krasovec the denotation of her heritage are the memories filled with joy at her Slovenian church as a little girl. Bernice Krasovec is a 3rd generation Slovenian, whom is also my grandmother. The many different traditions in which she treasures has impacted her life and those surrounding her. With 13 grandchildren and several great grandchildren Bernice Krasovec has shared many stories and traditions with her posterity to be carried on for years to come.

My great-grandparents emigrated to the United States around 1902. Grandma Bernice noted, "As I grew up the elders with Slovenian background were

very cautious in what they did. Thought they had more knowledge and experience. Helped guide the outline of my life." Bernice Krasovec grew up being half Slovak and Slovenian. Her great grandmother Marija Sinkovec Godec was a Slovenian, she emigrated from a village of Ambrus (at that time a part of Austro-Hungarian Empire, then Yugoslavia, now Slovenia), great-grandfather Cyprian Hiza was a Slovak, he emigrated from the region of Kute (at that time also a part of Austro-Hungarian Empire, then Czechoslovakia, now Slovakia).

Bernice was born in 1928, in Pueblo Colorado. Growing up in the early 30's she learned that family is the most important part of our life. Bernice had a lot of fantastic memories in which did not include electronic devices and Netflix. Those memories were not recorded on social media but have been remembered and passed down through the spoken word and through her published children's books.

Since the 1930's were very posh Bernice would have to learn about how to be a damsel in a dress while being a traditionally reserved lady. The Slovenian influence in Bernice's life has made her who she is today. Without the knowledge and respect for the Slovenian people she would not know where she and her family originate. "I think the best influencer taught me how to make the best dishes for holidays and regular times... I was popular in making the pastries!" The importance of Slovenian heritage goes more to the knowledge of the tradition and keeping them known.

"When holidays came, we would bake potica and would roll the dressing and dough on the table, which made the best memories." At Easter, the Zegen basket (which has been used by many generations) was carefully packed with food items representing Catholic beliefs. The Zegen basket was covered with a special, decorative cloth and brought to church on Holy Saturday to be blessed by the Bishop. On Easter morning, families would celebrate and partake in the blessed food which consisted mainly of traditional foods like ham (which represented Christ's body), potica (his crown of thorns), horseradish (symbolizing the nails with which Christ was crucified), eggs (representing the resurrection from the tomb), and

wine (symbolizing the blood of Christ or his bitter suffering). Bernice's family would also place a bag of gold coins in the basket. Every year, God willing, another coin would be added as a symbol of prosperity.

Bernice's home as a young girl was always smelling of the traditional scents of klobasa, potica, and strudel. As a young girl Bernice's family attended St. Mary's church which was a Slovenian based church. My Grandmother has met a lot of remarkable people, through her Slovenian heritage. "St Mary's Church always had social events in which my family attended. That was the only social life we had which was involved around our Slovenian church." In the 1930's the social incline persisted of church, school, and family. When my grandmother was home, she was helping with the chores or learning more about her ethnicity especially on Sundays. "Sunday afternoon, I would visit (Grandma Godec) my grandmother... who would share all of her knowledge on Slovenian history." My Grandma lived in a house full of love in which she would learn more about her family's choice in emigrating to the United States.

Bernice was trying to reclaim the memories which occurred in the 1930's. Her family valued the importance of Slovenian heritage and the memories made during the holidays. "We grew up that way, and everything was Slovenian... influenced by [our] Slovenian culture." This quote is to show growing before 1945 was very different than the millennials growing up as of right now.

Growing up in such a small community in Colorado my grandmother met many other Slovenians living in Pueblo since Pueblo was an area where many Slovenians immigrated. There she also found her husband Rudy Krasovec. Since her husband, my grandfather Rudy Krasovec, was a first-generation Slovenian his parents corresponded frequently with their family in Businja vas, Slovenia. My great grandfather Martin Krasovec emigrated so he would not fight in World War I, leaving all his siblings and relatives in Businja vas (what at that time was Austro-Hungarian Empire, then Yugoslavia, now Slovenia). Only to arrive in America and learn he would have to fight in WWI representing America.

He was sent to France and he fought in two major Allied counteroffensives in 1918, was wounded twice and came back to America as a decorated veteran of WWI. After my great grandparents passed away, Bernice continued the tradition with regular correspondence to my family in Businja vas. After my grandfather and Bernice's husband passed away in 1999 my Grandmother and family went to Slovenia to meet in person. Today, the distance is only felt by miles, and the Krasovec family has truly become one. The Krasovec family in both America and Slovenia have become family and together work to keep the traditions alive through wine making, sharing of recipes and visits.

Pueblo Colorado, was affected by the Slovenian people, not only have we grown roots in Pueblo the people have influenced the foods and traditions in the small community. Bernice Krasovec, the curator of the Gornick Slovenian Library, Museum and Genealogy Center is an incredible inspiration in learning about her own ethnicity has continued the Slovenian ways in her family in which her children and their children will celebrate the Slovenian traditions in the years to come. Slovenian ways have influenced so many people in America, it is important to remember where we came from and praise our elders and our rich traditions.

PALM SUNDAY BENEFIT DINNER. APR. 14, 2019. ST VITUS AUDITORIUM

St. Vitus Parish will hold its annual Palm Sunday benefit dinner on APR. 14, 2019 at 6111 Lausche Avenue, Clev., OH 44103 from 11:00AM to 1:30PM. Sit-down and take-out dinners will be available with cost at \$15 adult and \$10 child 12 years-old or younger. Support for Palm Sunday 2019 benefit event is for literacy and culture.

The Palm Sunday benefit dinner has been in continuous operation for 52 years with the first four decades to provide support for the temporal needs of the parish and the past 10+ years for one or more individuals or a charitable organization as beneficiaries. For example, 12 year-old child with cystic fibrosis and other physical and metal challenges; family with all three children having one form or another of autism; family where both children had A-T disease, a life threatening disease; orphanage in Mexico; support for Greater Cleveland Fisher House, support for US Military Veteran families; helping two local US Veteran Posts, and support for Joseph House of Cleveland Inc. to resettle incoming immigrants to Cleveland and its clothing distribution ministry. Over \$220,000 has been raised for these worthwhile individuals or organizations.

Palm Sunday 2019 benefit event is for two not-forprofit 501(c)3 organizations promoting literacy and culture: Slovenian Cultural Association and Friends of Slovenian National Home. Slovenian American Cultural Association supports the monthly bilingual publication "Slovenian American Times," and Friends of Slovenian National Home supports Slovenian National Home, 6409 St. Clair Avenue, the "Mother Home" of all Slovenian Homes in northeast Ohio. Literacy has been one of the most advocated values with Slovenians, even in the 19th and 20th centuries when Slovenia was predominately an agrarian society: access to higher education was primarily available to the upper class in Slovenia. Due to an extensive network of Catholic parishes in Slovenia and extended "primary" school network, the majority of rural households were taught reading and writing skills for many practical reasons.

Slovenian National Home was organized and established Aug. 17, 1914 as a meeting place in all its dimensions: choral concerts; theater plays; operettas; benefit dinners; annual Christmas gatherings; gathering site for special occasions; and a place where other nationalities could come together in peace and friendship.

This is a KSKJ Matching Funds event, meaning two local lodges, St. Vitus Lodge #25 and Christ the King Lodge #226, are each able to match up to a maximum of \$2,000 per lodge on funds raised. This is matched through the home office of KSKJ Life, a national benefit society based in Joliet, IL.

Only 500 dinner tickets will be sold. All donations raised prior and during this event will be split between the two organizations. The general public is invited to attend a reasonably priced meal, enjoy good company, come to Mass, and support the good work of these two organizations.
