




BISHOP BARAGA EDUCATIONAL CENTER CAPITAL CAMPAIGN

The mission of the Bishop Baraga Association (located in Marquette, MI) is to promote the life and labor of Venerable Frederic Baraga, who was a Slovenian missionary who came to the United States in 1830. In an effort to further that mission and preserve the home where Bishop Baraga spent his last years, the BBA is creating the Baraga Educational Center. The center will be located in the Baraga house at 615 S. Fourth St. in Marquette, MI.

The BBA has recently started a capital campaign for the development of this Educational Center. The association is committed to creating a place that will become a pilgrimage destination—to preserve the artifacts used by Bishop Baraga during his ministry. KSKJ Life has recognized the importance of this campaign and has made a commitment to this project.

As previously communicated, the Home Office will donate \$1 for every registered participant and for every shared photo to JDRF - Juvenile






