MATCHING FUNDS UPDATE

LODGE #50 AND THE SEASON OF GIVING

Gratitude. According to the dictionary, Gratitude is a noun and means the quality of being thankful; readiness to show appreciation for and to return kindness. Not that everyone needed to have a quick vocabulary lesson, but gratitude is something I wish more people used, especially in today's society when everyone tends to only think of themselves.

For this year's KSKJ Life Lodge 50's Matching Funds project, we teamed up with the Best of Batch Foundation for their annual Batch-A-Toys Toy Drive, matching the value of the toys received. For those who are not from Pittsburgh, the Best of Batch Foundation was founded in 1999 by retired Pittsburgh Steelers back-up quarterback Charlie Batch.

The Batch Foundation is a nonprofit organization devoted to improving the lives of children and families in distressed communities by building character, self-esteem, and appreciation for education. Currently serving southwestern Pennsylvania, Best of the Batch Foundation does good works, such as scholarships to college-bound students and a yearly back to school BatchPack book bag distribution to kids and teachers. Best of the Batch also offers programming that couple sports with learning—such as the seven-week summer basketball camp where participating boys and girls attend study halls where they read and discuss pre-selected books.

Four years ago, Lodge 50 did our first ever toy collection as a way to give back to our local community during the Holiday Season. Our first collection was with the Best of Batch Foundation, which our Fraternal Activities Coordinator heard Charlie Batch talk about on a local radio station. The following years we chose a few other organizations for our holiday toy collections and upon delivering the collections we didn't receive any gratitude for what we were doing for them. At our fall meeting, the motion was made that we go back to doing our Toy Drive collection for the Best of Batch Foundation as they have been the only organization truly grateful for what we have done and collected. We are pleased to announce that we will be collecting our annual Christmas Toy Drive for the Best of Batch Foundation for as long as they will accept us. When I dropped off the toys collected at the Best of Batch Foundation headquarters, I was greeted with a warm hug and a tour of their facilities.

I had the privilege to meet Charlie Batch when I dropped off the toys and had the chance to talk to him more about their Batch-A-Toys Toy Drive. Charlie was extremely transparent with me describing every detail of the process, all the way down to working with the school guidance counselors to choosing worthy children and families, to the wrapping parties, and to the Christmas Eve delivery where Charlie hand delivers the gifts to all 151 families. The school guidance counselors help the Batch Foundation determine what toys that the children would like and what necessities the families could use. Every family receives a comforter, towels, silverware, dish set, and pots and pans along with the toys for the children.

Charlie told me a story that brought tears to my eyes. Shortly after Christmas, he received a thank you card from a little boy who was more appreciative of having a spoon so he could eat his milk and cereal in the mornings for breakfast over having something to play with. That story made me think about my own life and how privileged I am to have grown up with the lifestyle I was raised.

I cannot be more thankful to our members and officers of Lodge 50 who donated \$760.00 worth of toys that will be matched as our 2018 Matching Funds project. It is a nice feeling knowing that we did something good to help those who are way less fortunate than most of us in our local community of Pittsburgh during the Holiday Season. Next year Lodge 50 is looking forward to helping the Best of Batch Foundation wrap presents and help pack up the U-Haul truck for delivering the gifts for the families.

As a New Year's Resolution for 2019, I am challenging each KSKJ Life lodge to think outside the box and find a way to do something special to give back to your own local community especially during the holiday season whether it be your own toy drive or volunteering at your local soup kitchen feeding the homeless. I think we have a lot to learn and a lot to be thankful for especially during the Holiday Season.

If you're living in a warmer climate, that doesn't mean you can't get in on the fun! There are loads of indoor ice skating rinks that will have you in the winter spirit in no time.


Activities with Kids

With a little imagination, there's plenty of activities to keep busy with this winter. Be sure to check your PerkSpot member rewards often for new and exciting deals!




