## A MESSAGE FROM THE KSKJ LIFE HOME OFFICE KSKJ LIFE AWARD 2018 NATIONAL AWARD RECIPIENTS



As a member-based organization, part of KSKJ Life's mission is to practice fraternalism and service by lending a helping hand to those in need. Each year, we recognize two deserving individuals who have demonstrated an exceptional commitment to this mission.

Heidi Coldagelli was chosen for KSKJ Life's 2018 National Service

Award. Heidi belongs to Sts. Cyril and Methodius Lodge #59 in Eveleth, MN. "Heidi is a busy mother of 2 who has a full-time job, yet she always finds time to volunteer in the community – not only through KSKJ Life, but also through her community, church and school," says friend and fellow Lodge #59 member, Amy Brazerol. Heidi has been very involved in coordinating the community's local March of Dimes Walk for Babies for the past several years. She was co-chair since 2004 for the event, which raised over \$50,000 each year.

Heidi also volunteers at her children's school, Marquette Catholic School in Virginia, MN. She has worked various fundraisers for the school and was formerly involved with their Home and School Association. In addition to her work at the school, Heidi has just volunteered to be on the finance committee at Resurrection Church in Eveleth, MN.

As part of her award, KSKJ Life is donating \$250 to Marquette Catholic School. Heidi explained that they have been making significant improvements to the school in the last few years. "The kids have a very small play area and the school ropes off part of the parking lot in order to give the kids a place to run, but it is still very small with no green space," says Heidi. Last month, the school tore down the old church that is next to the school with the intention of expanding the space for a new playground area. Heidi has earmarked the donation to be put towards the building of this new playground.

Jeanette Jensen was chosen for KSKJ Life's 2018 National Lodge Person of the Year. Jeanette belongs to St. Joseph Lodge #7 in Pueblo, CO. "Jeanette has served as our St. Joseph Lodge Hall manager since 2016 and has been actively soliciting events and rentals," says Chair of the National Board of Directors and fellow Lodge #7 member, Rudy Krasovec. "This is a primary source of income for the lodge and she has been instrumental in helping revitalize our building and significantly increasing events for the lodge. She has worked tirelessly fixing up the facility and preparing it for all the Lodge activities that are held at our hall."

As an active lodge member, Jeanette served on the Membership Committee for many years before she was elected as the Fraternal Activities Coordinator in 2019. This past year, Jeanette chaired the Mt. Carmel festival parking lot fundraiser, the Christmas Cookie Exchange event and Lodge 7's first Holiday Craft Show. She assisted her mother, Josephine Martellaro, her sisters and her many aunts cooking and serving members at our Palm Sunday breakfast. She is also one of the top sellers for tickets to lodge events.

Jeanette is also active on her community and routinely volunteers at St. Mary's Historic Catholic Church, serving on several of their committees. She helps cook and prepare dinners at the church and also participates with other fraternal groups in Pueblo. As part of Jeanette's award, she will also receive \$250 from KSKJ Life that will go towards the charity of her choice.



FIRST KSKJ HOME OFFICE

1909 - The very first KSKJ Office Building was built in Joliet, IL.



In 1938 KSKJ Life broke ground for their new office building, to be erected on the corner of Chicago and Crowley.



The second KSKJ Home Office was located just 2 blocks from the first Home Office site.

On March 22, 1981 this site on Glenwood Ave in Joliet for a new office building was dedicated as the official Home Office of KSKJ Life.



They didn't know it yet, but that building in the back was destined to become the 4th KSKJ office!


## KSKJ LIFE MEMBER STORIES

As part of our 125th Anniversary, we asked our members and their families that have been with us over the years to share their own, unique KSKJ Story. Each month we will feature a couple of the submissions received. Thank you Stane Kuhar and Kathy Kozek Gibbons for sharing your KSKJ stories with us!



### Stane Kuhar Wickliffe, OH Lodge #226

After my parents, Luka and Jozefa Kuhar (nee Rebolj) fled Slovenia in 1945 after the conclusion of World War II due to the imposition of Communism in Slovenia, my parents were placed in a displaced camp, Spittal, in southern Austria where they remained until 1950 until a "sponsor" from the USA, a distant relative of my father in upper Minnesota, to have them resettle there for one year. The first born child, only two months old, died in the displaced camp due to lack of needed medication. After the one time period they resettled in Cleveland, Ohio and remained there the rest of their lives. KSKJ lodges were affiliated with St. Vitus Parish and that made the transition to the USA a bit more comforting for them and other immigrant families. And KSKJ has been a part of our lives for over 65 years.



Luka, Jozefa and oldest living brother Lou, Kuhar by the "new" house purchased circa 1952 in Cleveland. Luka and Jozefa were married in the displaced camp of Spittal, Austria, at age 37 years-old each. First son, Janez, died due to lack of medication in the camp. Lou was born in 1951, then Francisek in 1952, Stane in 1953 and Bogomir in 1954.



### Kathy Kozek Gibbons

I have some very fond memories of attending Christmas parties at St. Stephen's Parish in Chicago, IL held by Lodge #1. I am a lifelong member of KSKJ Life and now I am approaching my 73rd year. The things I remember about the Christmas parties were that my brother and I are always received gifts which we were so excited about. At the party there was also a talent program. I had cousins that also belong to the lodge, and played the piano beautifully, but unfortunately I didn't have that talent nor did my brother. My mother once suggested that my brother and I put on boxing gloves and have a boxing match since we were very good at fighting with each other. I know we could have won first place for that one! Unfortunately they didn't go for our talent. These are great memories of my childhood. My grandfather, Antone Banich, was also very involved with Lodge #1. **THE STATE OF ILLINOIS DEPARTMENT OF INSURANCE ON JANUARY 23, 2019**

Bylaw Change Recommendation	Explanation
1. Replace phrase "Financial Board" to "Board of Directors" wherever it appears in the bylaws	Housekeeping – Since the Fraternal Board has been changed to a committee and only one "Board" remains according to the Bylaws, to avoid any confusion delete the term "Financial Board" and replace it with simply the term "Board."
2. Change name of "Screening" committee to "Nominating" committee wherever it appears in the bylaws	To be consistent with Robert's Rules of Order and regulatory requirements
3. Section 402-Delete the old paragraph and replace with the following:  <del>402. A member in good standing is a person who is in good financial standing in KSKJ Life. A person in good financial standing in KSKJ Life, and who is not a limited member, is considered an active member.</del> 402. A member in good standing is a person who <b>has an insurance</b> certificate (the insured) <b>and</b> is in good financial standing in KSKJ Life. A person in good financial standing in KSKJ Life, and who is not a limited member, is considered an active member.	Housekeeping – clarify that the <b>insured</b> person of a life or annuity policy is the member, not the owner or beneficiary.
4. Para 801-Delete the old paragraph and replace with the following:  <del>801. The supreme legislative body of KSKJ Life shall be composed of members of the Board of Directors, and delegates or alternates elected by the local lodges, as hereinafter provided, who shall vote in person only.</del>  01. The supreme legislative body of KSKJ Life shall be composed of members of the Board of Directors and qualified delegates, or seated alternates, elected by local KSKJ Life lodges, as hereinafter, who shall vote in person only.	Housekeeping – clarify that proxy voting is not permitted, particularly with alternates – need to vote in person.
5. Paragraph 902. Change dates for delegate election to between February 1 <sup>st</sup> – March 31 <sup>st</sup> .  902. Each active local lodge shall elect its delegates to the National Convention at either a regular or a special meeting to be held between <del>March 1st and April 30th</del> of the convention year.	Need more administrative time to adequately communicate with delegates and process travel reservations and requests, as well as make committee assignments and perform committee duties.
6. Paragraph 903. Delete sentence: " <del>Five active members must be present for a quorum and a meeting to be valid</del> " and replace with:  "In order to constitute a valid local lodge meeting for delegate election, it must consist of at least one of the following lodge officers: President, <b>Vice President</b> , Financial Secretary, or Fraternal Activities Coordinator, and a minimum of four (4) additional active lodge members.	Update language to ensure that at least one of the required three elected lodge officers – President, <b>Vice President</b> , Secretary, or Fraternal Coordinator – is present to preside at delegate election meeting.
7. Paragraph 904. Replace with new paragraph below.  <del>904. The Secretary of local lodge should publish a notice of meeting for election of delegates in the Official Publication. Said election shall be by public nomination and secret ballot and when three or more persons are nominated, a majority vote of the members present shall elect; if no one person receives a majority vote the two nominees receiving the most votes shall again be balloted upon and the one receiving a majority vote shall be elected. Local lodges entitled to more than one delegate shall elect each additional delegate according to the procedure specified above. After election of delegates, two or more alternates shall be elected. The first alternate elected shall fill any vacancy occurring in the delegates elected. The second and other alternates to fill the subsequent vacancies in the order in which they are elected. Official notification in writing of excused absence to the lodge president shall allow any eligible member to run for a convention delegate/alternate even though he/she is unable to be present at the election meeting.</del>  The lodge secretary should publicly communicate a notice of the meeting for election of delegates. Communication can be digital and should be made through KSKJ Life publications, email, and/or any other communications medium commonly used by their lodge members.  Said election shall be by public nomination and secret ballot. A majority vote of the members present shall elect the delegates and alternates to the National Convention. Lodges entitled to more than one delegate shall hold one election with the number of delegate positions listed on one ballot. Any individual who will not be able to attend the election meeting but desiring to run for a delegate/alternate position, shall give prior written notice to the lodge president stating the reasons	Simplify the delegate election process to one ballot. Highest vote getters are delegates, next in line are alternates.  Previous bylaw language called for each delegate position to be elected individually.

for said absence.. After nominations, members shall vote by inserting a different candidate's name into each of the available positions (candidates may vote for themselves). In order for a ballot to be valid and counted, all available positions must contain the name of a nominee. Ballots will be immediately tallied publicly before the voting members. The top vote getters will earn the available delegate positions.  The remaining nominees will be considered alternates and will fill any vacancies that may occur. Alternates will be assigned in descending order according to the highest remaining vote getters. Official notification in writing by any elected delegates withdrawing from their position is necessary before alternates are appointed to delegate positions. Any documentation regarding delegate changes should be submitted to the home office for record-keeping.	
8. Para 1001: Delete this paragraph: <del>1001. The National Convention shall be held quadrennially at the place selected by the last preceding National Convention. In the event no decision is made at the National Convention, the Board of Directors has the authority to select the site and date.</del>  and replace with the following:  "The National Convention shall be held quadrennially at a place and date selected by the Board of Directors."	Convention planning and contracting requires considerable negotiating and administrative time years in advance; needs to be a board approved function.
9. Para 1003 delete sub-para (11)  <del>(11) Selection of place for next National Convention.</del>	Related to #8 above.
Add new paragraph 1011: (replacing 1404, e) 10. All convention applications to the KSKJ Life Board of Directors shall be reviewed by the Convention Screening Committee. Screening Committee will be composed of KSKJ Life members from different member geographical locations to promote balanced representation from membership. Screening Committee shall review all board applicants for required qualifications as per KSKJ Life Bylaws, Board of Directors Guidelines, and State of Illinois and National Association of Insurance Commissioners (NAIC) governance regulations. The Screening Committee shall present a report to the National Convention for the delegates approval. Said report shall be the basis of the election of National Officers and Directors. Based upon other bylaw provisions and the requirements of the Illinois Department of Insurance for candidate background investigations and screenings, no new candidate applications or nominations will be accepted after the bylaw stated application deadline.	Adds new language regarding board qualifications and screening/nominating process.  No candidates will be accepted after the deadline because the Screening Committee will not have time to conduct and review the required investigative reports.
11. Para 1403 added language at end of section:  <b>1403.</b> All elected officers and directors shall hold office for a period of four years, beginning the first of the month after 30 days following the completion of the National Convention or until their successors are duly elected or appointed.  <b>ADD:</b>  Elected officers and directors must remain in good standing during their term on the Board. Failure to remain in good standing may result in removal of said individual from his or her position by action of the Board of Directors, and the vacancy shall be filled in accordance with these bylaws. However, in no event may an assessment obligation be forgiven, credited or repaid by whatever means in lieu of collection or reduction in benefits, unless provide to all members of KSKJ Life and approved in writing by the Illinois Director of Insurance. ## FINANCIALLY FIT IN 2019

*No Gym Required for These (Financial) Fitness Tips*

If you're like me, your social-media feeds are jammed with headlines about getting "healthy and fit" in the new year. Of course, they're referring to diet and exercise and common resolutions to drop pounds and work out more often.

But it's just as important to be concerned about your financial fitness—where you can also drop some baggage and get some strength training without going near a gym. (In fact, if you have a subscription to a gym membership but aren't going, that's one financial fix you can make right now.)

Here are some tips to consider for any age:

### IN YOUR 20s:

**Workout:** Have a portion of each paycheck deposited into your savings account or take advantage of bank programs that "round up" or have other automated savings features. Trust me, you won't feel this burn.

**Diet:** Start making coffee at home or at the office instead of going for expensive lattes. Fewer calories, and more money in your pocket. This is a good time to look into getting life insurance (whether you are single or attached) as it is less expensive the younger and healthier you are. Consider a term insurance policy and/or cash value insurance policy at this time. A term insurance policy provides coverage for a certain period of time, or a specified "term" of years.



If the insured dies during the time period specified in the policy and the policy is active then a death benefit will be paid. Cash value life insurance is a form of permanent life insurance that features a cash value savings component. The policyholder can use the cash value for many purposes, such as a source of loans, as a source of cash, or to pay policy premiums.

### IN YOUR 30s:

**Workout:** You probably have a retirement program at work or some other preliminary retirement planning in place. If you don't, start.

If you do, why not increase the amount you divert into retirement by a percentage point each year—equaling your company match percentage, if they have it, is a good target.

**Diet:** You may not have gotten life insurance beyond what you have through your workplace, but now is the time to consider an individual policy that you own. Remember, when you leave a job, you typically lose that life insurance offered through your workplace. And, given that life insurance through the workplace usually equals one or two times your salary (or a set amount like \$50,000), it's no longer going to cut it if you have a growing family.

If money's tight, as it often is with a growing family, lingering student loans, and perhaps a mortgage, a term life insurance policy can protect you through the lean years. But don't overlook the long-term benefits of a permanent life insurance policy. The cash value can be tapped later for needs that may arise. Plus, there's nothing that says you can't have a combination of both.

### IN YOUR 40s:

**Workout:** Navigating the ins and outs of a growing financial portfolio can be tricky as you move through your career and want to use traditional or Roth IRAs, and the tax benefits of various planning strategies. So it is important to do your due diligence and research these matters. This may also be the time that you can add a permanent life insurance policy, if you haven't before, which allows you to accrue cash value and obtain benefits that extend later into your life.

#### PALM SUNDAY BENEFIT DINNER. APR. 14, 2019. ST VITUS AUDITORIUM

St. Vitus Parish has held an annual Palm Sunday benefit dinner in its parish auditorium, 6111 Lausche Ave., Cleveland, Ohio for the 50+ years. The first four decades had funds raised to primarily support the temporal needs of the parish while the past 10 or so years one or more individuals or a charitable organization(s) were beneficiaries of this event. For

example, a 12 year-old child with cystic fibrosis and other physical and mental challenges; a family with all three children having one form or another of autism; a family where both children had A-T disease, a life threatening disease, most not surviving past the age of 25 years-old; an orphanage in Mexico was helped; supporting Greater Cleveland Fisher House, support for US Military Veteran families; helping two local US Veteran Posts, and more recently, support for Joseph House of Cleveland Inc. to resettle incoming immigrants to Cleveland and its clothing distribution ministry. And all were KSKJ Matching Grant events! On April 14, 2019, Palm Sunday, we will be promoting literacy and culture through two not-for-profit 501(c)3 tax exempt organizations. The two organizations we will be helping are Slovenian Cultural Association and Friends of Slovenian National Home.

Literacy has been one of the most advocated values with Slovenians, even in the 19th and 20th centuries when Slovenia was predominately an agrarian society: access to higher education was primarily available to the upper class in Slovenia. But due to the extensive network of Catholic parishes in Slovenia and extended "primary" school network, the majority of rural households were taught reading and writing skills for all with many practical reasons. Slovenians have had, and continue to have, a high literacy rate, often 90% or higher: current day Slovenia has a literacy rate at 99%. Due to its compact size and oversized regional neighbors (Italy, Austria, Hungary and Croatia), most Slovenians in the rural areas could speak and read or write in another language.

Slovenian National Home was organized and established on Aug. 17, 1914 to promote culture in all its dimensions and also have a place to meet with one another: annual choral concerts by mixed singing organizations; theater plays; a place where American Slovenian Catholic Union (KSKJ) lodges could meet on a regular basis, gathering site for special occasions such as the Independence of Republic of Slovenia in 1991; and also a place where other nationalities could come together in peace and friendship.


