

## CELEBRATING LODGE ANNIVERSARIES: LODGE #115

On March 24, 1907, St. Veronica's Lodge #110 was founded. And, on May 14, 1907, the lodge was admitted as part of KSKJ Life. Records indicate there were 22 charter members of this Kansas City, KS lodge.

St. Veronica lodge started like many of the other KSKJ Life local lodges with Slovenian immigrants leaving their villages in eastern Europe. Poverty, wars and the opportunity to better their future pushed many Slovenians to come to this country. These brave young people, knowing they may never see their families and friends again, made the voyage across the Atlantic Ocean to Ellis Island in New York. From there, they boarded trains and made their way to the Midwest.

It was the availability of work in the meat-packing industry and the mines that drew the immigrants to the neighborhood called the "Strawberry Patch" along the Kaw River bottoms in Kansas City. Even today, this community in Kansas City is still called Strawberry Hill, where the rich eastern European customs, heritage and beliefs still exist after all these years.

Lacking skills, schooling and familiarity with the English language, immigrants worked long hours, six days a week, for as little as \$.10 an hour. Sunday was a day of rest to attend Church and spend time with family and friends. Religious faith was very important to these new settlers.

As time went on, these early arriving Slovenes wanted very much to establish their very own church. In 1907, with \$1,800 in hand, they started the process of establishing their own parish. The new parish came to be known as Holy Family Roman Catholic Church, and it still exists today.

For more than 100 years, Holy Family Church and St. Veronica lodge have always worked hand-in-hand to assist with the spiritual and financial needs of its members. Today, St. Veronica lodge has grown to more than 700 members with many of its members enjoying the financial products, the additional benefits, charitable works, volunteerism, and social activities offered through KSKJ Life.

It seems like just yesterday that our lodge celebrated our 100th anniversary.

### KSKJ LIFE CELEBRATES THE FEAST OF MARIA POMAGAJ

On Wednesday, May 24, 2017, the Joliet Lodges will have their annual Mass for the feast of Maria Pomagaj, Our Lady of Brezje, the patroness of Slovenia and KSKJ Life. The Mass will be at St. Joseph Catholic Church in Joliet, IL at 6:30 p.m. This Mass will be offered for all KSKJ Life members living and deceased. KSKJ Life Joliet Regional Director Mary Mihelich and Father David Stalzer at St. Joseph Church started this annual event in May 1996. It was offered for the deceased members of Joliet KSKJ Life lodges who died in the past year. Fathers David Stalzer and George Klepec concelebrated the first Mass. Some years, the Mass has been held at St. Mary's Slovenian Catholic Mission in Lemont, IL, as a joint regional event with the Chicago Region.

Maria Pomagaj is the Slovenian depiction of Mary, Help of Christians. This painting is located in St. Vitus Church in Brezje Slovenia. The church of St. Vitus was built in the 15th century. It was a popular pilgrimage site with a painting of Mary based on a

well-known version in Innsbruck, Austria. In 1800, a chapel featuring the Virgin Mary was added to the church. In 1814, painter Leopold Layer painted frescos and the Slovenian rendition of Mary Help of Christians. He did so to fulfill a promise he had made to the Virgin, when he petitioned her for aid when the French had imprisoned him. In 1863, the first known miracle attributed to Our Lady of Brezje occurred and many prayers began to be answered. This caused an increase in the popularity of Brezje as a pilgrimage site. In 1907, the bishop, with approval of Pope St. Pius X, crowned the Christ Child and Mary. In 1988, Pope St. John Paul II gave the church the title of Basilica and he visited Brezje in 1996.

At the 41st International Eucharistic Congress, the Coordinating Committee of Slovenian Participants passed this resolution, "Every year on the eve of the feast of Our Lady of Brezje, Our Patroness and Protector of Slovenian heritage, we light a candle and spend the evening in meditation. We reflect on the Christian values and traditions that guided our people through the centuries, that mold us today and through us the nation where we live." Our Mass is celebrated in the spirit of this resolution.

Bringing the Slovenian tradition to America, St. Joseph Church installed a chapel and painting of Maria Pomagaj. The chapel and painting were dedicated on February 6, 1906. Viennese artist Jozef Kastner painted this beautiful interpretation of Maria Pomagaj. Ivana Sustersic, the mother of the first pastor, bought the painting. It has remained an important part of the church since.

All Slovenians and friends are welcome to come and join the celebration as an important part of our heritage. After Mass we will have a social gathering behind the church in Ferdinand Hall.

The program continues and has proven effective in preventing re-hospitalizations.

DiMare earned a Bachelor of Science in Nursing from Ursuline College in 1980 and became Certified in Hospice and Palliative Nursing in 2012.

She is the daughter of Tony and Dolores Mihelich, KSKJ Life members.


