Additional documentation is required as part of the application, including transcripts from the previous year, current proof of enrollment/class schedule and current photo/headshot of the applicant. With high school and college classes beginning this month, now is the perfect time to gather these required documents so you can take advantage of this member benefit.

The one-time \$1000 grant will be awarded to the eligible recipients in late fall 2017.

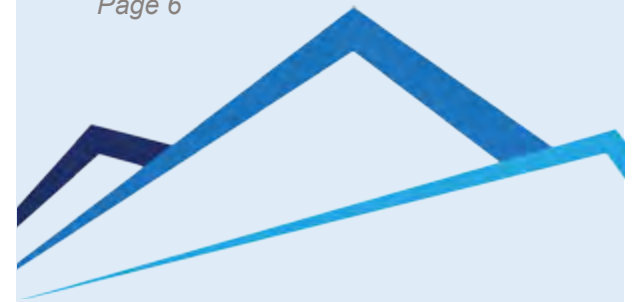

EDUCATIONAL GRANT SPOTLIGHT

As we approach the 2017-2018 school year, we caught up with two of our 2016-2017 educational grant recipients. They updated us on their schooling, work experience and volunteer efforts since receiving the KSKJ Life Educational Grant last year.



ALEYNA GOERLITZ

Lodge #136 member Aleyna Goerlitz is currently in the physical therapy clinical doctorate program at the University of Wisconsin La-Crosse. In her physical therapy program last year, she was required to complete substantial observation hours, which included time in local schools. At those schools, she had the privilege of assisting a variety of disabled or delayed children engage in activities that ranged from riding a bike, to kicking a ball, to balancing blocks on a tray. "The pure joy I witnessed on the faces of these kids as they progressed in activities they were once unable to participate in made my time more than worth it," said Aleyna.

She is currently volunteering with the EXPAND program (Exercise Program for Adults with Neural Disorders), helping an individual who has neurological deficits and assisting at an Adaptive Sports League for teenagers in the area. "Similar to KSKJ Life's mission, such [opportunities] allow me to connect and serve others in a thoroughly selfless manner that [leaves] me satisfied to claim joy as my own profit."



DOMINIC CEVASCO

Lodge #110 member Dominic Cevasco graduated this past May from Ohio State University with a degree in accounting. He is currently working at PwC (PricewaterhouseCoopers) in downtown Columbus, Ohio.

Dominic recalls that his favorite volunteer experience happened when he was going through his Confirmation class in his junior year of high school. Dominic's group went to a local food pantry in Akron, Ohio to serve hot meals to the homeless and struggling families. He said the best part was being able to help those who were less fortunate than himself. "KSKJ Life's mission is based upon the idea of Christian charity, and I believe that the love I felt at the pantry was a reward from God for taking care of his children."

CELEBRATING LODGE ANNIVERSARIES: LODGE #44

Founded June 22, 1893, the Knights of St. Florian Lodge #44 was run independently for one year, eventually joining the Bohemian Catholic Union for a time, following the pattern of other lodges situated in Chicago and Joliet, Illinois. On August 22, 1897, the Knights of St. Florian joined KSKJ Life.

The founding fathers were: Frank Medosh, Anton Kosicek, James Sebohar, Anton Skala, Math Sute, Carl Medosh, Frank Frankovich, Peter Brletich, John Kucic, Nick Pozek, Math Zimerman, Joe Furanich, Joseph Mavretich, Paul Kekich, John Henigsmann, Joseph Puh, Joseph Adamich, Joseph Osenik, George Simonovich, Joseph Petretich, Anton Jurincich, John Mausar, Mark Vuksinich, Tom Mordush and Jacob Bacnik.

The officers initially elected were: Frank Medosh, president; James Sebohar, lodge representative; Carl Medosh, secretary; and Anton Kosiek, treasurer.

It was at the time of the affiliation of the Knights of St. Florian and KSKJ that the famous drill team, in striking blue and red trimmed uniforms, led every parade in the South Chicago area. Complete with black belts and shining swords, they were an imposing sight to behold in all community activities, and active in all church presentations. They were, moreover, instrumental in 1903 by helping to build St. George's Slovenian Catholic Church at 96th Street and Ewing Avenue.

William F. Kompare, a prominent attorney in the South Chicago area, served as president from 1928 until his death in 1959. (He held the longest presidential term!) In 1973, Lodge #44 was merged with St. Joseph Lodge #220, West Pullman, Illinois.

Congratulations on your 120th anniversary, Lodge #44!

In June's edition of The Voice, we reported on the passing of Reverend Blasé Chemazar, OFM. Father Blasé was our lodge's Spiritual Advisor for 21 years and a KSKJ Life member for 87 years. In December, 2016, Lodge #1 honored Father as a Lodge Leader and Lodge Person of the Year. Though he was not able to be at our Christmas party to receive his awards, we mailed them to him with the congratulations and best wishes of Lodge #1 members.

Through the years, Father attended many lodge events. One event, St. Stephen Lodge's 120th anniversary, stands out in memory. On that day, as Father celebrated the Mass, he told a very detailed history of the founding of KSKJ Life and the lodge in the homily. Many commented that they appreciated hearing the KSKJ Life history.

Father spent numerous hours in the Franciscan Retreat House where he welcomed people from all walks of life. Last year, at my visit here in Lemont, I saw how he tried, with great effort, to get to his car to drive to the Retreat House. Father was especially fond of the Slovenian people who came to the U.S. after World War II; he understood the difficulties they experienced in a country far away from their native country. Father was a good listener, had a great sense of humor, liked history and his homilies were drawn from life and were contemporary and direct... Father Blase, we are thankful to God for the gift of your life. May your work and dedication be blessed in heaven; may the perpetual light shine upon you; may you rest in peace."

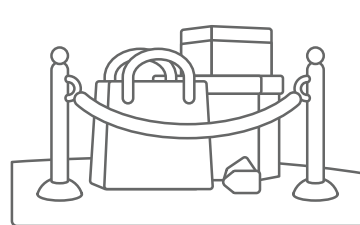

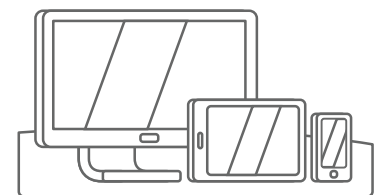
