Know that our prayers and best wishes are with each of you and your loved ones as we approach the blessings of Thanksgiving and Christmas!



On September 25, 2021, the Minister for Slovenians abroad, Dr. Helena Jaklitsch, visited with KSKJ Life's Rudolph Krasovec, Chair of the Board; Tony Mravle, CEO; and April Sleyko, VP of Sales and Marketing.

Accompanying Dr. Jaklitsch was Alenka Jerak, Consul General of the Republic of Slovenia in Cleveland; Dr. Zvone Zigon, Director of the Division for Slovenians Abroad; and Dr. John P. Vidmar, Honorary Consul of the Republic of Slovenia for Illinois.

During this visit, we had a chance to sit down with Dr. Jaklitsch to discuss the importance of her recent visit to the United States. Here is what Dr. Jaklitsch had to say:

"I simply want to say "thank you" to all American-Slovenians for trying to preserve their Slovenian identity, heritage and culture. Slovenia is celebrating 30 years of independence, and I want to tell [them] how thankful we are for what they did to help with its independence. Truly, the support from American-Slovenians was amazing. We wouldn't have been recognized so fast without their involvement. I want to express my gratitude.

My goal visiting here is to bring the pride of heritage that I witnessed [here] back home to Slovenia so they understand what American-Slovenians are doing to preserve their heritage. And I'd like to encourage Slovenia to support all of these efforts from these communities in the US.

It was so difficult for Slovenian communities all around the world to come together during the Covid-19 pandemic, so this visit was critical timing to be able to come here in person and be connected, especially during a difficult time."

### MINISTER'S VISIT TO THE UNITED STATES



#### Q: What are your impressions about the Slovenian Communities you have visited so far?

A: I was happy to see how active everyone is trying to stay and their efforts in growing their impact within communities. Many communities still have strong Slovenian roots, but I wasn't aware of so many until my visit. The communities we visited and the people I met felt like home. Everyone is very welcoming. I also noticed that Slovenian communities are trying to engage more young people in activities and are finding modern ways to express and engage on their own terms.

#### Q: What similarities have you noticed in the people of Slovenia and American-Slovenians in the US? (Same values/attributes)

A: All were very open and hospitable. The Slovenian food is the same in both countries which was comforting. Slovenian songs/music is the same, but what struck me the most was the way we think is similar. Our core values are the same, and that was very rewarding for me to identify.

#### Q: Why is it important for the country of Slovenia to stay connected with people of Slovenian descent in the United States?

A: "They are our people - we all belong to same Slovenian nation."

#### Q: What would you like to see American Slovenians do?

A: I'd like to encourage everyone to visit Slovenia and come more often and bring their children and grandchildren so they can see the beauty of the country and see why it's important to stay connected and honor their heritage and learn more about their Slovenian roots.

Q: You received a doctoral degree in 2016 and wrote your thesis on Slovenian schools in refugee camps in Italy and Austria from 1945 to 1950. A number of our members travelled thru the refugee camps in Italy and Austria in the late 1940s; what can you tell us about what you learned about those camps, the role of the Slovenian schools, and their impact on the refugees emigrating to the Unites States?

A: I'd like to really emphasize that Slovenians back then (in the camps) had an amazing story. What they organized in those camps in so unique in Europe. There were over 100k refugees and approximately 6k were Slovenians, but it was the Slovenians who created and organized an education system that started in the camps. The gimnazija (similar to a high school prep school in the US) were really impressive and were recognized by the British alliance as one of the greatest/best schools. It is important to point out that at this time, they had nothing (no books, supplies, etc.) so it's really something. The cultural lifestyle was also amazing.

Because the camps were run so well, when the refugees immigrated to the US, they continued to work in the same manner as they did when they were in the camps; they helped build the infrastructure within Slovenian communities in United States and Argentina. It was important to maintain Slovenian heritage and to develop these new communities as Slovenian communities. Through the same strong work ethic as the Slovenians portrayed in the camps, it fostered a strong bond locally. Need to take in consideration that they didn't even have basic needs met - no food, electricity, or heat.

After the war, we were taught that we are not nation who can make decisions alone and for those decisions to only serve a singular purpose. Everyone has a responsibility to take care of their land – not rely on someone else to take care of it. We embrace the fact that we are responsible for our own people, for our future. We have to do our best to serve our community and our nation and use the knowledge and wisdom from the past. The same spirit that ran through the refugee camps among Slovenians is the same spirit I see today and the same spirit I witnessed among Slovenian communities in the US.
