Through 2021 and today, Chris has continued to amplify his credentials by becoming a member of Million Dollar Round Table (MDRT) — the premier association of financial professionals. They represent the top 1% of producer's insurance professionals world-wide. And during Chris' 25-year tenure he has qualified 6 times for Top of the table and 5 times Court of the Table.

In 2005, Chris then moved his financial services practice to the Molyneaux Financial Group, LLC, a general agency of Massachusetts Mutual Life Insurance Company. While he was there, he received the Impact Award in 2006 and Management Council and Leaders Conference Honors in 2007. This agency eventually became MassMutual Chicago.

In 2010 he founded the LEGACY WEALTH GROUP, where he continues to lead a team of highly skilled professionals, while still developing his clientele nationwide.

Over the years, his leadership and financial expertise has been recognized by numerous magazines including Crain's, Chicago Business, GQ, Black Enterprise and African American Career World, Insurance News and most recently on the cover of the National publication "Advisor Magazine."

Going back to his roots, Chris also keeps his passion for sports in the forefront by donating and giving back wherever he can. In 2012, he became a member and

currently sits on the Board of the Chicago Concussion Coalition — an organization dedicated to making amateur sports safer for children.

He also serves on the Board of Directors for the Urban League, Naperville's ALIVE youth center, IAMABEL foundation and is also part of the United Way's Young Community Leaders.

A proud supporter of his community, he also volunteers for the Big Brothers/Big Sisters organization and the YMCA.
